Pick Your Prize Promotion – Official Rules

NO PURCHASE, DONATION, OR PAYMENT OF ANY KIND IS NECESSARY TO WIN. Purchase/Donation will not improve chances of winning. Odds of winning depend on number of entries received. The Sunmark “Pick Your Prize” (“the Sunmark Shen Promotion”) is sponsored by Sunmark Credit Union. This promotion is governed by these Official Rules (“Official Rules”). Sunmark shall be entitled to interpret these Official Rules as needed – including but not limited to rules regarding entries, deadlines, winner selection, prize restrictions, and eligibility – and all of its decisions are final. By participating in the Sunmark Shen Promotion, you agree to abide by all of these Official Rules and waive any right to claim ambiguity in these Official Rules or any other promotion -related advertising or materials. The Sunmark Shen Promotion is subject to all federal, state and local laws and regulations and is void where prohibited by law.

1. **Eligibility.** The Sunmark Shen Promotion IS OPEN ONLY TO LEGAL U.S. RESIDENTS UP TO AGE 25. IF YOU DO NOT MEET THESE ELIGIBILITY REQUIREMENTS, OR ANY OTHER REQUIREMENTS IN THESE OFFICIAL RULES AS OF ENTRY DATE, YOU ARE NOT ELIGIBLE TO PARTICIPATE OR WIN A PRIZE. In addition, entrants must have Internet access, a valid e-mail account, and a contact number that can receive text messaging prior to entry. Sunmark reserves the right to shorten or extend the Sunmark Shen Promotion at their sole discretion.
3. **How to Enter.** Participant must open a Student Checking Account between May 1, 2024 and May 31, 2024 . 4. **Prize.** All new Student checking members at the Shen Sunmark branch location up to age 25 who open their account during the promotion period, as well as the alternate entries, will be entered into a drawing done by Sunmark Credit Union to win a \$100 gift card of their choosing.
5. **Selection and Notification of Winner.** At the end of May, Sunmark will randomly draw two winners for the prize. Winner will be issued an IRS 1099 INT tax form (or its equivalent) for the actual prize value awarded.
